






RARE SPECIES

The NW corner of Wisconsin is the meeting point of several biomes and, as a result, the home of many rare species surviving at the edge of their range. As the landscape type itself is now uncommon in our state, many of the Pine Barrens' endemic flora & fauna are in short supply. Our namesake, the Sharp-tailed grouse, is not the only example, but the most charismatic of these creatures. Karner Blue Butterfly, Kirtland's Warbler, Blanding's Turtle, and a host of others all rely on the Pine Barrens ecosystem to survive. Maintaining habitat for these critically rare species is our top priority.

Objective # 5 Influence Both State of Wisconsin and Local Governmental Decisions, That Will Benefit Sharp-tailed Grouse and Suitable Open Landscapes With an Emphasis on Quality Barrens Habitat;

• 24. Allow training, trialing and hunting without dogs being on an 8-foot leash (090220, 510120)

• Current state regulations limit the training and trialing of dogs because of concern on the impact on nesting birds. On State owned land open to public hunting and are not designated open to dog training under NR17.05, dogs shall be controlled by a person using a leash which is no more than 8 feet in length from April 15, to July 31.

 Various hunting dog owners and associations such as the Wisconsin Association of Field Trial Clubs, The Wisconsin Association of sporting dogs, the Wisconsin Wildlife Federation, the Wisconsin Bear hunters Association and the Wisconsin Coon hunters Association support these changes.




The Motts Ravine area has been identified as capable of supporting and expanding the globally rare and imperiled pine-barrens community type. What We Accomplished So Far ...

- Supported , sponsored, and conducted sharptail workshops, seminars, symposiums and various meetings throughout the state.
- Provided input to management plans for county forests, state forests, WDNR wildlife areas and federal properties.
- Lobbied for continued existence and enlargement of STG mgnt. areas and continued regulated hunting for sharptails.
- Providing funds for acquisition and habitat management, sharptail research and translocation.
- Contribute funding for Crex Meadows wildlife Education and Visitor Center and the WI Breeding Bird Atlas I & II
- Cooperated with US Forest Service and WI & MN DNRs in a major trap and translocation project to increase sharptail numbers on Moquah Barrens WA
- Joined other non-profit barrens oriented organizations to network for wildlife conservation and aided establishment of Friends groups at Douglas Co. and Namekagon Barrens Wildlife Areas.
